Mr. Phillips is a Maine Certified Soil Scientist, and was a New Hampshire Certified Soil Scientist and a New Hampshire Certified Wetland Scientist up to 2004. Don has over 20 years of environmental consulting experience in Maine and New Hampshire, assisting hundreds of land development projects through the permitting process since the mid 1980's. These projects included several wetland mitigation projects that he designed throughout Maine that successfully underwent long-term post-permitting monitoring. He taught a Fall semester soil science course at *Unity College In Maine* from 1998 to 2002, including a wetland science class there in 2003 and 2005. An accomplished field ecologist and botanist, Don has identified both unique natural communities and rare and/or threatened plant species during fieldwork. Don credits a Georgia-to-Maine thru-hike of the Appalachian Trail back in 1978 for solidifying an interest in the outdoors and making him aware of the need for sound land use planning.
